The 'Manager of the Year' will be awarded to the most outstanding manager in the retail industry in Singapore, who is aged 31 or above as at 30 April 2017.

Judging Criteria:

- Leadership qualities
- Commitment to the company's success
- Achievements and contributions to the company and the retail industry in terms of how the manager has raised the standards, profile and image of the company and the retail industry in Singapore

Eligibility:

- The Award is open to all Singaporean / Permanent Resident managers in the retail industry in Singapore, who are aged 31 or above as at 30 April 2017, and are working in retail companies that are Ordinary Members of the Singapore Retailers Association.
- He / she must be holding at least a managerial position, and managing at least two levels of staff eg. supervisors and rank and file.
- The application can be for any eligible manager from any department within the company.
