

Best New Entrant of the Year

The 'Best New Entrant of the Year' will be awarded to the most outstanding new store that entered the retail scene in Singapore for the first time under a new store name within the qualifying period of 1 May 2015 to 30 April 2016.

Judging Criteria:

- Creativeness and uniqueness of the new entrant in terms of how it engages its target customers through its store design, display, merchandising, branding, positioning, etc
- Excitement in terms of the retail experience
- Success in terms of sales performance / consumer response / objectives met
- Impact on the retail industry in terms of how the new entrant has changed the retail landscape / raised the standards, profile and image of the retail industry in Singapore

Eligibility:

- The Award is open to all new 'brick and mortar' stores which have been operating under a <u>new</u> store name in Singapore for less than one year as at 30 April 2016.
- The store must have entered the retail scene in Singapore for the first time within the qualifying period of 1 May 2015 to 30 April 2016.
- The application can be for a department store, specialty store, supermarket or hypermarket.
